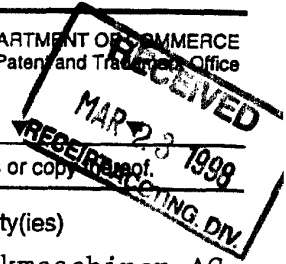

MACHINE FRAME AND METHOD OF MANUFACTURE THEREOF

AND I hereby authorize the Commissioner of Patents and Trademarks to issue any and all Letters Patent of the United States on said invention or resulting from said application and from any and all divisions and continuations thereof to the said corporation as the assignee of the entire right, title and interest in and to the same.
