DEED OF ASSIGNMENT

THIS DEED OF ASSIGNMENT is made the *14th* day of *June* 1994

BETWEEN: ANDREW PAISLEY SOMERVILLE

W H E R E A S:

- A. The Assignor is a co-owner with the Assignees of designs relating to "Bathroom and/or laundry accessory" (the "designs") and is a co-owner with the Assignees of design registrations in respect of the designs detailed in the Schedule hereto (the "design registrations").
- B. The Assignor has agreed to assign to the Assignees all of the Assignor's right, title and interest in the designs and the design registrations including any copyright in the designs and in any artistic work corresponding to or included in the designs on the terms and conditions set out in a Deed of even date between the Assignor, the Assignees (the "Deed").

NOW IT IS AGREED AS FOLLOWS:

- 1. In consideration of the covenants obligations and agreements contained in the Deed, the Assignor hereby assigns to the Assignees without limitation all his interest in the designs and the design

registrations including any copyright in the designs and in any artistic work corresponding to or included in the designs together with all rights of action, powers and benefits associated therewith.

2. The parties agree that upon execution hereof the Assignees shall be entitled to have the design registrations proceed in their names alone.
3. The parties agree to execute all documents and do all acts, matters and things necessary to complete the assignment to the Assignees of the design registrations and in particular but without limiting the generality of the foregoing to have the design registrations proceed in the names of the Assignees alone and to have the designs registered in the names of the Assignees alone.
4. The provisions contained in the Deed shall not merge herein and shall continue in full force and effect save to the extent that they are hereby performed.
5. The parties acknowledge and agreed that nothing in this Deed shall act to derogate from the rights and entitlements of the Assignor as set out on clause 4 of the Deed.
