AND I HEREBY authorize the said Assignee, its successors, assigns, or other legal representatives, to make application for and to receive Letters Patent for said


invention in any of such countries in its own name.

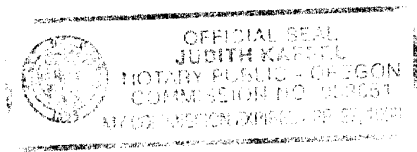
