WHEREAS, DANA R. COLDREN, a resident of Fairbury, IL 61739-9550, MARVIN P. SCHNEIDER, a resident of East Peoria, IL 61611-1480, and COLIN T. TIMMS, a resident of Middlesex, Great Britain, hereinafter referred to as ASSIGNORS, have invented a new and useful

ELECTRONIC FUEL INJECTOR WITH INTERNAL
SINGLE-POLE SOLENOID AND CENTER FLOW POST

for which they are about to file an international application and/or make application for Letters Patent in the United States of America, such invention being described and identified by said application having an attached International Application Request and/or an attached Declaration and Power of Attorney executed by ASSIGNORS respectively on October 31, 1997, November 3, 1997 and October 31, 1997; and

2. At the request and expense of ASSIGNEES, ASSIGNORS agree to communicate to ASSIGNEES any facts known respecting said invention, to execute all papers necessary to file any application on said invention and to perfect said title in ASSIGNEES, and to generally do everything necessary or desirable to aid ASSIGNEES in obtaining and enforcing proper protection for said invention in the United States of America and any foreign country.

3. ASSIGNORS hereby authorize and request the COMMISSIONER OF PATENTS AND TRADEMARKS to issue the United States Letters Patent on said invention, when granted, to CATERPILLAR INC. AND LUCAS INDUSTRIES PUBLIC LIMITED COMPANY.

4. This assignment shall inure to the benefit of ASSIGNEES, their successors, assigns and other legal representatives, and shall be binding upon ASSIGNORS, their heirs and legal representatives.
