ASSIGNMENT

WHEREAS, WE, **Mark A. Swart, Charles J. Johnston, Gordon A. Vinther and Steve B. Sargeant**, residing at 5329 E. Tisbury Court, Anaheim Hills, California 92807; 411 Los Gatos, Walnut, California 91789; 103 South Roosevelt Avenue, Pasadena, California 91107, and 10322 Lassen Street, Los Alimitos, California 90720, respectively, have invented certain new and useful improvements disclosed in an application for United States Letters Patent entitled **TEST SOCKET**, and executed by us on even date herewith;

AND WE HEREBY covenant that we have full right to convey the entire interest herein assigned, and that we have not executed, and will not execute, any agreement in conflict herewith;

AND WE HEREBY further covenant and agree that we will communicate to ASSIGNEE any facts known to us respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, substitute and reissue applications, make all rightful oaths and generally do everything possible to aid ASSIGNEE to obtain and enforce proper patent protection for said improvements in all countries.
