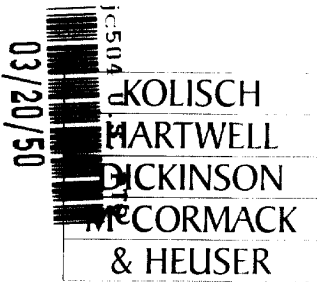



Multimedia Products Corporation dba Rosen Product Development, Inc., its successors and assigns.


