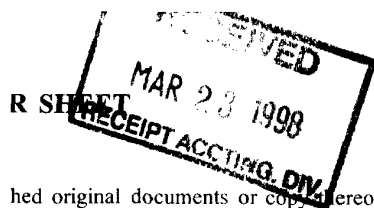


WHEREAS, the undersigned, hereinafter referred as Assignors, have invented new and useful improvements in:
