






WHEREAS, We, Shu Long Li and Robert C. Arnott, citizens of the United States of America, residing respectively at 204 Woodgrove Trace, Spartanburg, SC , County of Spartanburg, State of South Carolina and 173 Striblin Circle, Spartanburg, SC 29301, County of Spartanburg, State of South Carolina, have invented certain new and useful improvements in **POLYAMIDE COATED AIRBAG FABRIC** as set forth in U.S.Patent Application # 08/980,926 filed December 1, 1997; and

WHEREAS, MILLIKEN RESEARCH CORPORATION, a Corporation, organized under the laws of the State of South Carolina and located at Spartanburg, in the County of Spartanburg and State of South Carolina, is desirous of obtaining the entire right, title and interest in, to and under the said improvements and the said application:
