2. Authorize Assignee to file patent applications in any or all countries for any or all of said inventions and discoveries in our names or in the name of Assignee or otherwise


as Assignee may deem advisable, under the International Convention or otherwise.

3. Karl Hermann Zierhut, born on 22 February 1936, last resident at Waldperlacher Str. 21, 81739 Munich, died on 10 March 1997.
