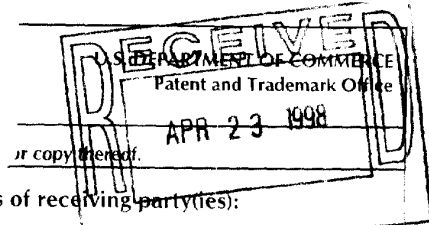

ASSIGNMENT
