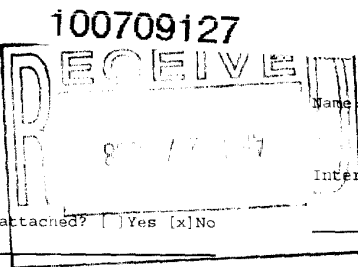

ASSIGNMENT






