WHEREAS, we, **Michael M. Tso**, 5744 SE Preston Court, Hillsboro, OR 97123, citizen of Australia, **David A. Romrell**, 14 NE Tandem Way, #147, Hillsboro, OR 97124, citizen of the United States, and **Bikram S. Bakshi**, 2599 NW Overlook Drive, Suite 823, Hillsboro, OR 97124, citizen of India, have invented the subject matter described in the United States Patent Application entitled "SYSTEM FOR DELIVERY OF DYNAMIC CONTENT TO A CLIENT DEVICE," filed in the United States Patent and Trademark Office on December 30, 1997 and assigned Serial No. 09/000,709; and

And we hereby authorize **Intel Corporation** to file patent applications in any or all countries on any or all of said invention in our name or in the name of **Intel Corporation**, or otherwise as **Intel Corporation** may deem advisable, under any International Convention or otherwise.

And we hereby authorize the Commissioner of Patents and Trademarks of the United States and the empowered officials of all other governments to issue or transfer all said Letters Patent to **Intel Corporation**, as assignee of the entire right, title and interest therein or otherwise as **Intel Corporation** may direct in accordance with this instrument of assignment.

We hereby represent and warrant that there are no rights or interests inconsistent with the rights and interests granted herein and that we will not execute any instrument or grant or transfer any rights or interests inconsistent with the rights and interests granted herein, and we hereby bind ourselves and our heirs, executors, administrators and legal representatives, as the case may be, to execute and deliver to **Intel Corporation**, its successors and assigns, any further documents or instruments and do any and all further acts that may reasonably be deemed necessary by **Intel Corporation**, to enable **Intel Corporation**, its successors or assigns to file applications for the invention in any country where it may elect to file such applications, and that may be necessary to vest in **Intel Corporation**, its successors and assigns, the title herein conveyed or intended so to be, and to enable such title to be recorded in the United States and foreign countries where such application or applications may be filed.






