ASSIGNMENT

Whereas We, Abram Klaas Roskam, who reside at Notcolaan 42, Sleeuwijk 4254 CD, Netherlands, Jan Aart van Bekkum, who reside at Groeneweg 69, Hoornaar 4223 MG, Netherlands, and Vladimir Smychliaev, who reside at Slangenburg 140, Dordrecht 3328 DS, Netherlands, have made certain inventions or discoveries (or both) set forth in an application for Letters Patent of the United States of America entitled **ULTRASOUND RATE OF FLOW MEASUREMENT METHOD AND DEVICE**, identified by Cesari and McKenna File No. 15804-0044, which application was executed by us on 2nd April 1997; and




