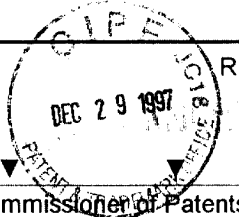

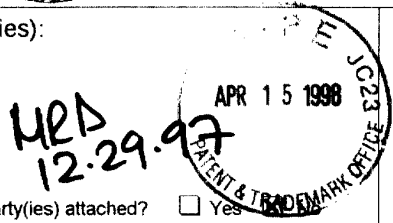

ASSIGNMENT

WHEREAS, Bing Bing Zhu of Northridge, California; Monty Mong Chen Fu of Canyon Country, California; and Richard L. Green of Simi Valley, California, Assignors, have invented a new and useful dual purpose shielded container for a syringe containing radioactive material, for which an application for United States Letters Patent was filed on May 30, 1997 and assigned Application No. 08/866,920;

recording or maintaining the title of Assignee, its successors and assigns, to the invention, the application, and any Letters Patent granted for the invention in the United States and throughout the world.


Assignors represent and warrant that they have not granted and will not grant to others any rights inconsistent with the rights granted by this Assignment.
