## ASSIGNMENT

WHEREAS, Thomas D. Nielsen is the inventor of the invention described and claimed in U.S. Patent No. 4,315,538, entitled "Method and Apparatus to Effect a Fine Grain Size in Continuous Cast Metal" and which issued on February 16, 1982;

Whereas, Thomas D.
