
ASSIGNMENT

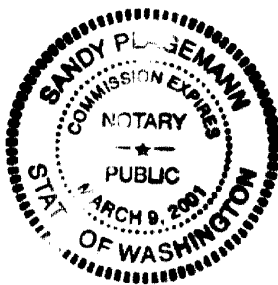
