ASSIGNMENT

WHEREAS, we, Rudolf Edgar Falk, of 57 Rose Park Drive, Toronto, Ontario, M4T 1R2 and Samuel S. It is agreed that ASSIGNOR shall be legally bound, upon request and at the expense of the ASSIGNEE or its successors or assigns or a legal representative thereof, to supply all information and evidence of which the undersigned has knowledge or possession, relating to the making and

practice of said invention, to testify in any legal proceeding relating thereto, to execute all instruments proper to patent the invention in the United States of America and foreign countries in the name of the assignee and to execute all instruments proper to carry out the intent of this instrument.

If ASSIGNOR includes more than one person, these obligations shall apply to those persons both individually and collectively.


ASSIGNOR hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this assignment.






