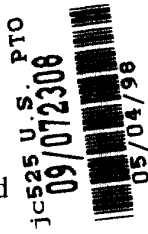

Whereas I, Robert S. Cartwright Jr., who reside at 36 Fifth Lane, Chelmsford, Massachusetts 01824, have made certain inventions or discoveries (or both) set forth in an application for Letters Patent of the United States of America entitled Encoding Machine-Specific Optimizations in Generic Byte Code by Using Local Variables as Pseudo-Registers, identified by Cesari and McKenna File No. 112047-0002, which application was executed by me on 30 April 1998; and

5.
