

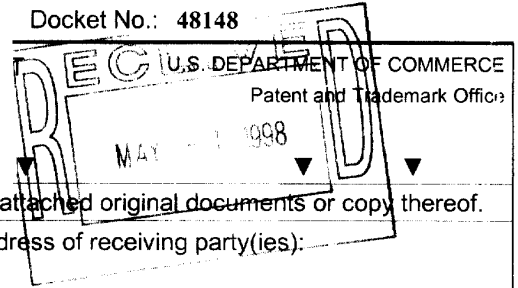



successors and assigns, to obtain, maintain and enforce patent protection for said invention in all countries.






