

**TERMINATION AND RELEASE OF PATENT  
AND TRADEMARK SECURITY AGREEMENT**

This Termination and Release of Patent and Trademark Security Agreement, dated as of March 2, 1998, by and between Fleet Bank-NH, a bank organized under the laws of the State of New Hampshire with an address of Mailstop NHNA E02A, 1155 Elm Street, Manchester, New Hampshire 03101 ("Fleet") and Vutek USA Inc., a Nevada corporation with a principal place of business of 189 Waukewan Street, Meredith, New Hampshire 03253 ("Vutek USA"). Vutek Inc., a New Hampshire corporation with a principal place of business at 189 Waukewan Street, Meredith, New Hampshire 03253 ("Vutek") is the legal successor to Vutek USA.


Fleet was the secured party under a certain Patent and Trademark Security Agreement executed by Vutek USA and Fleet dated March 20, 1997 (the "Security Agreement"), recorded with the Patent and Trademark Office at Reel 8412 Frame 0206, on March 24, 1997.

Vutek has fully satisfied its obligations under the Security Agreement, and the Security Agreement has terminated.

Now therefore, for valuable consideration, the receipt and adequacy of which are hereby acknowledged, Fleet does hereby reassign, relinquish, terminate and release forever the Security Agreement, and hereby assigns and transfers to Vutek all right, title and interest of any nature whatsoever which Fleet holds in the Patents, Trademarks, and the Collateral, as those terms are defined in the Security Agreement, including, without limitation, the patents listed on Exhibit A attached hereto effective as of the date set forth above.

Fleet further agrees that it shall execute all documents and do all other acts necessary to relinquish and effect the release of such rights.
