## ASSIGNMENT

WHEREAS, WE, **Mark K. Goldstein, Larry (NMI) Deshazer, Aleksandr S. 
AND WE HEREBY covenant that we have full right to convey the entire interest herein assigned, and that we have not executed, and will not execute, any agreement in conflict herewith;
