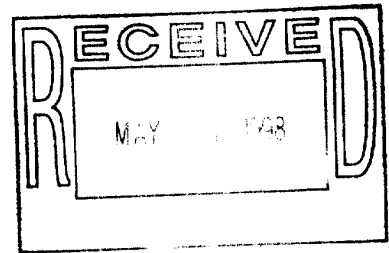

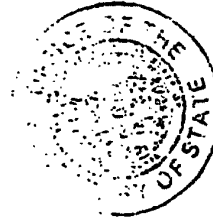

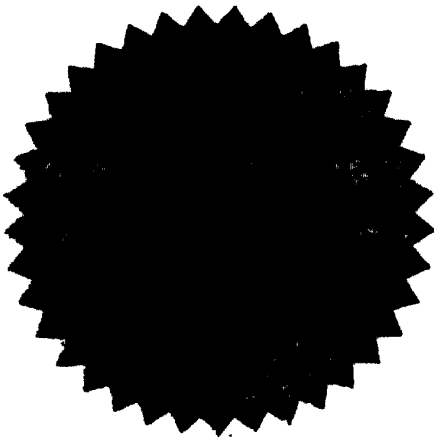

2. Article I of the Articles of Incorporation of this corporation is hereby amended to read in its entirety as follows:


"The name of the corporation is Health Hero Network, Inc."

The corporation has three classes of stock. The number of outstanding shares is 3,400,000 shares of Common Stock; 2,000,000 shares of Series A Preferred Stock and 1,030,000 shares of Series B Preferred Stock. The percentage vote required was more than 50% of the outstanding shares.
