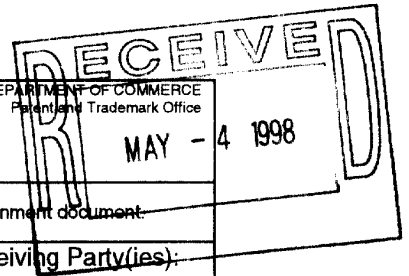


SERIES CAPACITOR INK SENSOR FOR MONITORING LIQUID DEVELOPER MATERIAL
