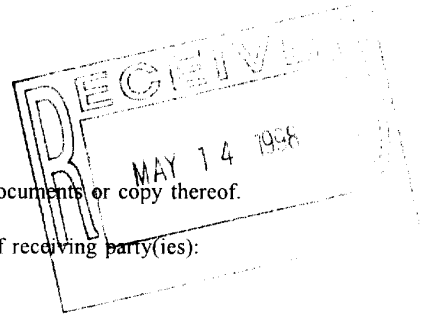

ASSIGNMENT
