
**ADDENDUM**

**THIS ADDENDUM** to the **AGREEMENT**, dated February 5, 1998, made this 19<sup>th</sup> day of March 1998, by and among The Evergreen Group Incorporated, a corporation organized and existing under the laws of the State of New York U.S.A., and having a principal place of business at 300 Atlantic Street, Suite 301, Stamford, Connecticut 06901 (hereinafter called "Evergreen", Richard P. Pursuant to paragraph 4 of the Agreement, in the event that the reorganization of Permit is not completed with Evergreen's equity participation and said Agreement is rescinded, then Evergreen shall reassign to Sturtevant and to E Ten their ownership rights in the '502 Patent which were assigned to Evergreen under paragraph 1 of the Agreement.




