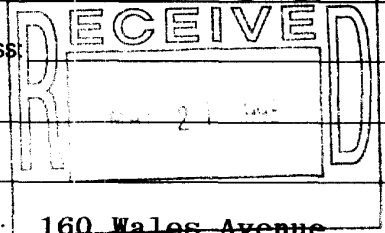



March, 1998, under Serial No. 29/085,633




