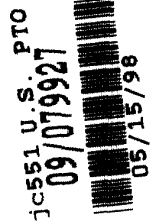



improvements and all applications for patents and all patents on said improvements in Assignee; and


