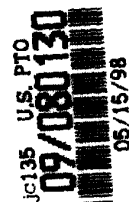




assigns, to obtain and enforce proper patent protection for said inventions in this or any foreign country.
