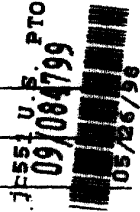

ASSIGNMENT

WHEREAS, I, DIAN-QING YANG, a Canadian citizen, whose full post office address is 738 Myrand Avenue, Apt. 1, Sainte-Foy, Québec G1V 2T9, Canada, have invented certain improvements in

INTEGRATED METHOD FOR PROTECTING LOGS AND GREEN LUMBER FROM SAPSTAIN AND MOLD

for which an application for a patent for such invention is to be filed in the United States of America;

The assignor further undertakes and agrees to execute such documents as may be necessary and proper to enable the assignee to obtain and maintain patent protection for the said invention in any country.
