AND I HEREBY covenant that I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, any agreement in conflict herewith.

AND I HEREBY further covenant and agree that I will communicate to the said Donghia Furniture Co., Ltd., its successors, legal representatives and assigns, any facts known to me respecting said designs, and testify in any legal proceeding,


