ASSIGNMENT AND AGREEMENT





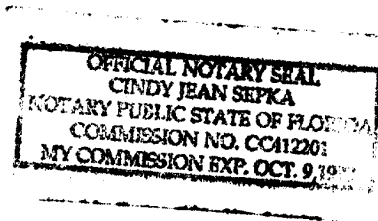
