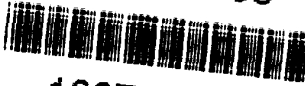

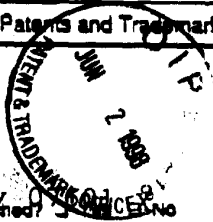

## ASSIGNMENT OF PATENTS

**WHEREAS, EDWARD MARKOWITZ**, an individual with a post office address at Continental Plaza, 411 Hackensack Avenue, Hackensack, New Jersey 07601 ("Assignor"), has invented certain new and useful improvements in inflatable stuffing for footwear, handbags and similar items for which United States Letter Patents were granted or for which an application for patent is pending, all as more particularly set forth on **Schedule A** hereto (collectively, the "Patents");

**NOW THEREFORE**, for good and valuable consideration, the receipt of which is hereby acknowledged, Assignor by these presents has sold, assigned, transferred and set over, and by these presents sells, assigns, transfers and sets over unto Assignee and its successors, assigns and legal representatives, effective this 28th day of May, 1998, his entire right title and interest, for all countries, in and to the inventions described in the Patents and all the rights and privileges under any and all such patents that may be granted therefor and industrial property protection, including, without limitation, all applications for patents, utility models, and designs which may hereafter be filed for said inventions in any country or countries foreign to the United States, together with the right to file such applications and the right to claim for the same the priority rights derived from said United States applications under the Patent Laws of the United States, the International Convention for the Protection of Industrial Property, or any other international agreement or the domestic laws of the country in which any such applications are filed, as may be applicable; and all applications for industrial property protection, including, without limitation, all applications for patents, utility models, and designs which may hereafter be filed for said inventions in any country or countries foreign to the United States, together with the right to file such applications; and all forms of industrial property protection, including, without limitations, patents, utility models, inventors' certificates and designs which may be granted for said inventions in any country or countries foreign to the United States and all extensions, renewals and reissues thereof.

I hereby authorize and request the Commissioner of Patents and Trademarks of the United States and any Official of any country or countries foreign to the United States, whose duty is to issue patents or other evidence or forms of industrial property on applications as aforesaid to issue the same to Assignee, its successors, assigns and legal representatives, or to such nominees as it may designate.


I agree that, when requested, I will, without charge to Assignee but at my sole expense, sign all papers, take all rightful oaths, and do all acts which may be necessary, desirable, or convenient for securing and maintaining patents for the inventions in any and all countries and for vesting title thereto in Assignee, its successors, assigns and legal representatives or nominees.

I authorize and empower Assignee, its successors, assigns and legal representatives or nominees, to invoke and claim for any application for patent or patent or other form of protection for the inventions filed by it or them, the benefit of the right of priority provided by the International Convention for the Protection of Industrial Property, as amended, or by any convention which may henceforth be substituted for it, or any other international agreement or the domestic laws of the country in which any such application is filed, as may be applicable, and to invoke and claim such right of priority without further written or oral authorization from me.


