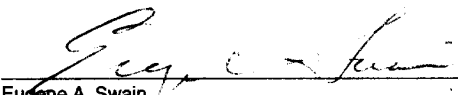
COATING METHOD

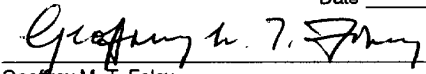
