NOTICE OF TERMINATION OF SECURITY AGREEMENT

This Notice of Termination of Security Agreement is made and entered into as of this 27<sup>th</sup> day of April, 1998 between ACCESS Radiology Corporation (the "Company") and Fleet National Bank (the "Bank").

WHEREAS, the Company and the Bank are parties to that certain Security Agreement (Patents) signed May 16, 1997 (the "1997 Patent Security Agreement") and recorded with the Patent and Trademark Office on June 2, 1997, Reel 8535, Frame 0970; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Company and the Bank agree as follows:


1. The 1997 Patent Security Agreement (Reel 8535, Frame 0970) is hereby terminated.
