Release of Security Interest and Registration

Whereas, Simulog Inc., a corporation organized under the laws of the State of Delaware, whose address is c/o Yoav Lavi, 11 Kazan St. Raanana, 43611 Israel ("The Debtor"), is the owner of a record of United States Letters Patent No. 4,697,241 ("The Patent") and;

Whereas, Amdahl Corporation is a Delaware Corporation having offices at 1250 East Arques Avenue, Sunnyvale, California 94088-3470 ("The Secured Party") and;

Whereas, in order to give the Secured party collateral securing the fulfillment of certain obligations the Debtor has undertaken towards the Secured Party, the Debtor agreed and caused the registration with the US Patent and Trademark Office of a Security interest of the Patent ("The Security Interest") and;


