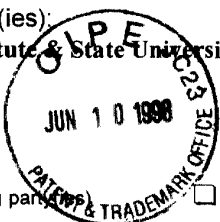

WHEREAS, Virginia Polytechnic Institute and State University, (hereinafter referred to as **ASSIGNOR**), an institute of higher education organized under the laws of the Commonwealth of Virginia, having an office and principal place of business at Blacksburg, Virginia, is the owner of the entire right, title and interest in and to application for United States Letters Patent Serial No.09/006,991, filed on January 14, 1998, in the names of Michael J. Purey and Czeslaw Kajdas for **WEAR REDUCING COMPOSITIONS AND METHODS FOR THEIR USE** and of the invention therein described; and
