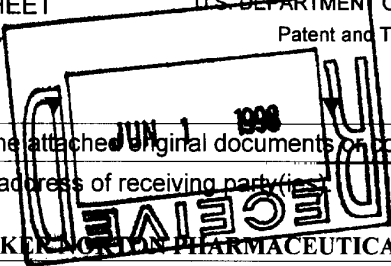

## **ASSIGNMENT**

WHEREAS, JOSE C. GUTIERREZ-ROCCA, JANICE L. CACACE, SAMI SELIM, ROBERT TESTMAN and J. The ASSIGNORS hereby authorize and request the COMMISSIONER OF PATENTS AND TRADEMARKS to issue Letters Patent which may be granted for said invention to the ASSIGNEE as the assignee of the entire right, title and interest therein.


