We will, at the Company's expense, perform all lawful acts which the Company, its successors, assigns, nominees and legal representatives may deem advisable to carry out the true purposes and intent hereof and we will assist the Company, its successors, assigns, nominees and legal representatives, in every lawful way to obtain, sustain and enforce Letters Patent for said invention, in all countries of the world, as and when requested by the Company, including specifically, but without limitation, the following:

- (a) we will communicate to the Company all facts known to us respecting said invention;
- (b) we will, as and when requested by the Company, execute all lawful papers which the Company may deem advisable for carrying out the true purposes and intent hereof, including all lawful oaths and affidavits, one or more written confirmations of this assignment, all applications for Letters Patent in foreign countries and all divisional, continuation, reissue and substitute applications for Letters Patent for said invention;
- (c) we will testify in any legal proceedings which involve said invention or any Letters Patent granted therefor.

We acknowledge and agree that the obligations recited herein are binding on us and on our heirs, executors, administrators and assigns forever.
