## ASSIGNMENT

WHEREAS, WE, Duane G. Hemphill and Joie L. Folkers, residing at 5 Sycamore Circle, Burkurnett, Texas 76354; and 2417 Merrimac, Wichita Falls, Texas 76308, respectively, have invented certain new and useful improvements disclosed in an application for United States Letters Patent entitled **THIN WALL FIBERGLASS PIPE CONNECTORS**, filed March 20, 1998, Application No. 09/045,050.
