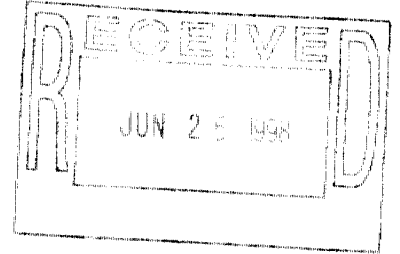

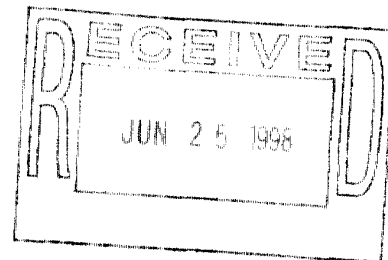



WHEREAS:


