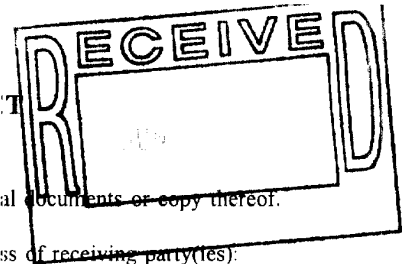


WHEREAS, the undersigned, hereinafter referred as Assignor, has invented new and useful improvements in:


