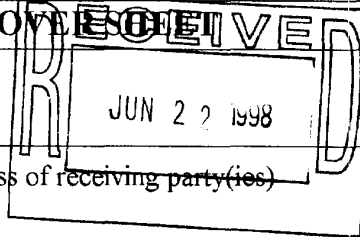

FACE SEAL FOR RESPIRATOR



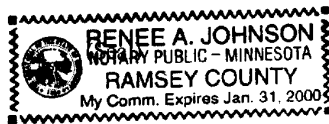


