

have invented certain new and useful improvements in a **ACCURATE DOSE NITRIC OXIDE PULSE DELIVERY DEVICE WITH MONITORING AND ALARMS**, for which we have signed a *DECLARATION AND POWER OF ATTORNEY FOR PATENT APPLICATION* of the United States, of even date herewith; and

AND WE HEREBY covenant that we have full right to convey the entire interest herein assigned, and that we have not executed, and will not execute, any agreement in conflict herewith.




