WHEREAS, **Branislav M. ASSIGNORS specifically agree, upon request of **ASSIGNEE**, and without further remuneration, to execute any and all papers desired by **ASSIGNEE** for the filing and granting of foreign applications and the perfecting of title thereto in **ASSIGNEE**.
