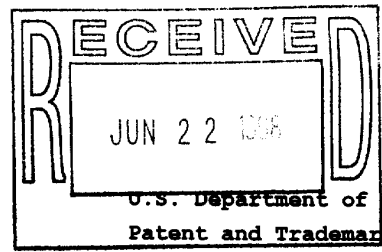

have invented a new and useful process, machine, manufacture, composition of matter, or an improvement thereof, entitled:

VEHICLE SUSPENSION SYSTEM INCLUDING ARCUATE TORSION MEMBER
