

AND, I HEREBY covenant that I have the full right to convey the interest assigned by this Assignment, and I have not made and will not make any agreement in conflict with this Assignment;

AND, I HEREBY further covenant and agree that I will, without further consideration, communicate with ASSIGNEE, its successors and assigns, any facts known to me respecting this inventive subject matter, and testify in any legal proceeding, sign all lawful papers when called upon to do so, execute and deliver any and all papers that may be necessary or desirable to perfect the title of this inventive subject matter in said ASSIGNEE, its successors and assigns, execute all divisional, continuation, and reissue applications, make all rightful oaths and declarations and generally do everything possible to aid ASSIGNEE, its successors and assigns, to obtain and enforce proper patent protection for this inventive subject matter in the United States and any foreign country in North America and South America, it being understood that any expense incident to the execution of such papers shall be borne by the ASSIGNEE, its successors and assigns.
