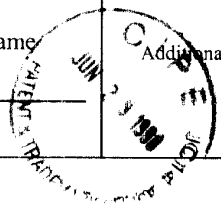

WHEREAS WE, DONALD V. GASBARRO of Mountain View, California; and RICHARD DEWITT CRISP of San Jose, California have invented certain new and useful improvements in a *High Frequency Bus System* for which invention we have executed an application for Letters Patent of the United States and which application may be identified in the United States Patent and Trademark Office as Serial No. 08/938,084, filed September 26, 1997; and


