
ASSIGNMENT

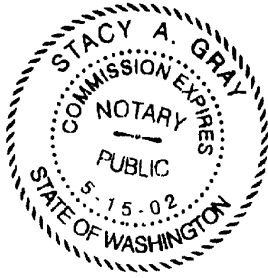

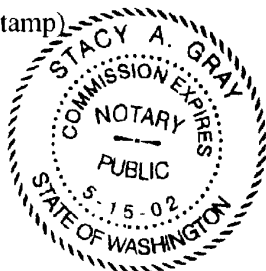
