UPON SAID CONSIDERATIONS, we do hereby agree with the said assignee that we will not execute any writing or do any act whatsoever conflicting with these presents, and that we will, at any time upon request, without further or additional consideration but at the expense of the said assignee, execute such additional assignments and other writings and do such additional acts as said assignee may deem necessary or desirable to perfect the assignee's enjoyment of this grant, and render all necessary assistance in making application for and obtaining original, divisional, continuation or reissued Letters Patent of the United States and in making application for and obtaining Letters Patent of any foreign country on said invention(s) as referred to herein before, and in enforcing any rights or choses in action accruing as a result of such applications or patents, by giving testimony in any proceedings or transactions involving such applications or patents, and by executing preliminary statements and other affidavits, it being understood that the foregoing covenant and agreement shall bind, and inure to the benefit of, the assigns and legal representatives or assignor and assignee;

And we request the Commissioner of Patents to issue any Letters Patent of the United States which may be issued for said inventions to said AGFA-GEVAERT its legal representatives, successors or assigns as the sole owner of the entire right, title and interest in and to said patent and in the United States in and to the invention covered thereby.
