PATENT ASSIGNMENT

WHEREAS, I, Stanley Weinberg, a citizen of the United States of America, residing at 575 Tigertail Road, Los Angeles, California 90049, (hereinafter "ASSIGNOR") have obtained Letters Patent of the United States of America for a "MINIATURE AIR PURIFIER", bearing patent number 5,484,472, and issued on January 16, 1996; and

ASSIGNOR hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Assignment.


